RACE WAIVER

RELEASE OF LIABILITY AND ASSUMPTION OF RISK

In consideration of the services of the ELEVATION RUN/WALK, Conifer Lobos Unified Boosters (CLUB), Conifer Chamber of Commerce, Conifer Area Council, Conifer Community Church, Jefferson County School District No. R-1, Jefferson County Open Space, and their agents, owners, officers, volunteers, sponsors, participants, employees, and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred to as "ELEVATION RUN/WALK"), I hereby agree to release and discharge ELEVATION RUN/WALK, on behalf of myself, my children, my parents, my heirs, assigns, my executors and administrators, personal representative and estate as follows:

1. I acknowledge that the activities involved in the use of any of ELEVATION RUN/WALK's services or facilities, at this location and all other locations, both run/walk and non-run/walk related, entail significant risks, both known and unknown, which could result in physical or emotional injury, paralysis, death, or damage to myself, to property, or to third parties.
 2. I expressly agree and promise to accept and assume all of the risks existing in these activities, both known and unknown, whether caused or alleged to be caused by the negligent acts or omissions of ELEVATION RUN/WALK. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks.
 3. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless ELEVATION RUN/WALK from any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity including any such claims which allege negligent acts or omissions of ELEVATION RUN/WALK.
 4. Should ELEVATION RUN/WALK or any one acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.
 5. I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I have no medical or physical conditions which could interfere with my safety in this activity, or else I am willing to assume and bear the costs of all risks that may be created, directly or indirectly, by any such condition.
 6. I agree that the validity and enforceability of this Release of Liability and Assumption of Risk will be governed by the substantive law of Colorado, without regard to its conflict of law rules.
 7. I agree to abide by the rules of the facility, including but not limited to school property and county roads and open space parks.
 8. If I bring a dog I will maintain control of my dog on a leash and pick up after it.

 10. I acknowledge that photographs of the event, participants, and spectators will be taken and I agree to allow such photos to be used in any marketing capacity seen fit by the ELEVATION RUN/WALK planning committee.
